**CAIS AM DENDRAU – CAE IDOLE A CHYFFORDD PWLL Y BAW I CYFFORDD
GLANMORLAIS**

Gwahoddir tendrau ar gyfer torri gwair Cae Idole, gyferbyn Adeilad Ysgol Idole, Idole, Caerfyrddin ac ymyl y ffordd rhwng cyffordd Pwll y Baw a cyffordd Glanmorlais, Glanmorlais, Cydweli.

Mae rhaid torri gwair y cae chwarae ac ardaloedd o gwmpas o ddiwedd mis Mawrth (amodau'n caniatáu) nes diwedd mis Hydref a'i gynnal mewn ffordd dderbyniol i'r Cyngor. Bydd rhaid torri'r gwair hyd ymyl pob ffin. Tendir i fod yn seiliedig ar 15 i 16 toriad yn ystod cofnod y cytundeb h.y. dau doriad pob mis. Yn ychwanegol dylid cario allan 2 toriad o du ôl ac ochrau'r cae chwarae yn ystod y cyfnod.

Cynnal dwy broses sbeicio yn cae Idole yn ystod y tymor torri i gynorthwyo draenio.

Mae rhaid torri ffin yr heol rhwng Pwll y Baw a cyffordd Glanmorlais (ar yr A484) rhwng diwedd mis Mawrth (amodau'n caniatáu) nes diwedd mis Hydref a'i gynnal mewn ffordd dderbyniol i'r Cyngor. Bydd rhaid torri'r gwair hyd ymyl pob ffin. Tendir i fod yn seiliedig ar 8 toriad yn ystod cofnod y cytundeb h.y. un toriad pob mis.

Dylid symud toriadau gwair o'r ddau safle yn dilyn pob toriad.

Rhaid cwblhau'r gwaith mewn cydymffurfiaeth gyda chanllawiau Cyngor Sir Caerfyrddin ar reoli ffiniau heol er mwyn diogelwch a bioamrywiaeth.

Bydd rhaid dychwelyd tendrau mewn amlen wedi'i marcio "tendr" i'r Clerc erbyn Dydd Iau 4ydd Chwefror 2021.

Ni does rhaid i'r Cyngor derbyn unrhyw dendr neu'r tendr isaf ac ni codi'r unrhyw daliad tan archwiliwyd a chymeradwywyd y gwaith.

Dylai pris y tendr fod net o TAW a dylai darparu statws TAW'r person yn darparu'r tendr gyda'r rhif TAW yn cael ei darparu i'r Cyngor ble'n briodol.

**REQUEST FOR TENDER – IDOLE FIELD AND PWLL Y BAW JUNCTION TO
GLANMORLIAS JUNCTION**

TENDERS are invited for the grass cutting of the Idole field. Situated opposite the Idole School Building, Idole Carmarthen and the grass verge between Pwll y Baw junction and Glanmorlais Junction, Glanmorlais, Kidwelly.

The playing field and surrounding area must be cut from the end of March (conditions allowing) until the end of October and maintained in a reasonable and low cut condition acceptable to the Council. The grass cutting must be to the edge of all boundaries. The tender to be based on 15 to 16 cuts during the contracted period. i.e. two cuts per month. Additionally 2 cuts of the area to the rear and sides of the fenced playing field to be carried out during the period.

Carry out two spiking processes of the Idole field during the cutting season to aid drainage.

The roadside verge between Pwll y Baw and Glanmorlais junction (along the A484) must be cut from the end of March (conditions allowing) until the end of October and maintained in a reasonable and low cut condition acceptable to the Council. The tender to be based on 8 cuts during the contracted period. i.e. one cut per month.

Grass cuttings should be removed from both sites following each cut.

All work must be in compliance with Carmarthenshire County Council guidelines regarding 'Managing Road Verges for Safety and Biodiversity'.

The Tenders must be returned to the Clerk no later than Thursday 4th February 2021 in an envelope marked "tender".

The Council does not bind itself to accept the lowest or any Tender received and payment will not be made until the works have been inspected and approved.

Tender price quoted must be net of VAT and the VAT status of the person tendering must be known to the Council with the VAT number provided where appropriate.

A copy of a current Public Liability Policy must also be submitted with the Tender. Should you require any further information please contact the Clerk as above.
