### 3. Public Participation

It was noted that no Members of the public were in attendance on this occasion.

- Permanently remove from the land the building erected from stacked shipping containers with an arched roof, including the shipping containers it is constructed from;
- Permanently remove the redundant concrete batching hoppers associated with the ceased B2 use of the site

The notice period was 3 months. The notice came into effect on 30/09/2025 and the compliance deadline was 30/01/2026. Noted.
