It was agreed to continue with the services of the Play Inspection Company.

3. 2026 Grass Cutting Contract

The Clerk noted that the current contractor had suggested a cost of £2,352 for the 2026-27 year, the cost for 2025 had been tendered at £2,415. However the final charge was confirmed to have been £2,254.

It was agreed to retain the services of Michael Leefe for the 2026 season.

4. Amenity Inspection Report

The Clerk presented a review of the condition of the Council Amenities following inspection. The report was noted.

8. Community Handyperson

The Clerk confirmed 28 hours worked in January with a cost of £644.00 agreed.

A suggested hourly rate of £24.00 was proposed for 2026-27 (£23.00 in 2025-26). The continuation of the Handyperson contract with Michael Leefe was approved for the 2026-27 year.

Council discussed possible Community Events in 2026 as follows:

10. 2025-26 Welsh Language Scheme Report

The Clerk presented the draft annual report to the Welsh Language Commissioner on the Council compliance with its Welsh Language Scheme. The report was approved and signed by the Chairman for return.

11. 2024-25 Completion of Audit of Financial Statements

The Clerk presented the 2024-25 Financial Statements following completion of the Audit by Audit Wales. The audit had provided an unqualified audit opinion. The Clerk noted that the financial statements and notice of conclusion of audit had been published as required.

The Clerk was thanked for his work with the Council Annual Financial Statements.

12. 2026-27 Precept, Priorities and Budget Report

The Clerk presented the report and noted the likely financial position for the end of the 2025-26 Financial Year.

Council considered the report and agreed to request a precept of £34,000 for 2026-27 (£31,000 in 2025-26). The sum would lead to a Band D Council Tax of £52.51 (£47.44 in 2025-26). The Chairman and Clerk were authorised to complete and sign the necessary paperwork to be returned to Carmarthenshire County Council.

The Clerk confirmed that it was good practice for Council to hold between 3 months and one year's precept in general reserves and that any further funds held should be allocated in specific reserves.

Council further considered its priorities for Council reserves. Specific reserves were agreed to be allocated as follows:

Public Lighting Improvements (including the annual £1,077.25 cost of the LED Lighting upgrade)	£3,000
Amenity Improvements	£2,000
Defibrillators	£1,000
Idole Play and Amenity Area	£7,000
